PLANNING AND ZONING COMMISSION: The Planning and Zoning Commission's responsibility is to make recommendations to the City Council regarding land use issues, including zoning requests, subdivision plats, changes to the Zoning Ordinance, amendments to and updates of the Comprehensive Master Plan and other items included in the physical development of Krugerville. The Commission usually meets the 2nd Thursday of the month at 7:00 p.m.
