

RESOLUTION NO. 20-0225-A

A RESOLUTION OF THE CITY OF KRUGERVILLE DECLARING UNOPPOSED CANDIDATES IN THE MAY 2, 2020, GENERAL CITY ELECTION, ELECTED TO OFFICE; CANCELLING THE SATURDAY, MAY 2, 2020, ELECTION; AND FINDING AND DECLARING THAT THE MEETING AT WHICH THIS RESOLUTION IS ADOPTED WAS OPEN TO THE PUBLIC, THAT THE PUBLIC NOTICE OF TIME, PLACE, AND THE SUBJECT MATTER OF THE PUBLIC BUSINESS TO BE CONSIDERED WAS POSTED AS REQUIRED BY LAW, INCLUDING THIS RESOLUTION.

WHEREAS, the General City Election was called for Saturday, May 2, 2020, for the purpose of electing members to the City Council; and

WHEREAS, the City Secretary has certified in writing that there is no proposition on the ballot, that no person has made a declaration of write-in candidacy, and that the candidates for Council Member Places 2, and 4, and Mayor on the ballot are unopposed for election to office; and

WHEREAS, under these circumstances, Subchapter C, Chapter 2, Election Code authorizes the City Council to declare the candidates elected to office and cancel the election for Council Member Places 2, 4, and the Mayor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KRUGERVILLE, DENTON COUNTY, TEXAS:

Section 1: The following candidates, who are unopposed in the Saturday, May 2, 2020, General City Election, are declared elected to office, and shall be issued certificates of election following the time the election would have been canvassed:

**George Wilthers – Council Member, Place 2
Grant Wills, Council Member, Place 4
Jeff Parrent, Mayor**

Section 2: That Saturday, May 2, 2020, General City Election is cancelled, and the City Secretary is directed to cause a copy of this Resolution to be posted on Election Day at each polling place that would have been used in the election.


Section 3: It is declared to be the intent of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Resolution are severable, and if any phrase, clause, sentence, paragraph, or section of this Resolution is declared invalid by the judgment or decree of a court of competent jurisdiction, the invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Resolution since the City Council would have enacted them without the invalid portion.

Section 4: The Krugerville City Council hereby finds, determines, and hereby declares that the meeting at which this Resolution is adopted was open to the public, that the public notice of time,

place, and the subject matter of the public business to be considered was posted as required by law, including this Resolution.
