4. **Discuss and take action on a request for variance to Chapter 14, Zoning, Section 6-6, Sign Regulations from Erik Schuyler, with Schuyler Signs, to install a nonconforming sign on the commercial property located at 4900 Highway 377, S, in the City of Krugerville, Denton County, Texas, as it lies in the overlay district, and in consideration of the following:**
 - **The Permanent Signs Table prohibits wall signs greater than 200 sf. and covering more than 10% of the primary wall area.**
Landowner is requesting a 280 sf sign, 35' x 8'.
