

**CITY OF KRUGERVILLE, TEXAS  
ORDINANCE 2017-0223-B**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KRUGERVILLE, TEXAS, AMENDING CHAPTER 12, TRAFFIC AND VEHICLES, ARTICLE 12.300 STOP SIGN PLACEMENT AND ENFORCEMENT, SECTION 12.301, OF ITS CODE OF ORDINANCES BY PLACING STOP SIGNS AT THE NORTH AND SOUTHBOUND LANES OF JOHNSON LANE & NEW HOPE ROAD AT CORTES STREET; THE NORTHWEST CORNER OF SHERRY LANE WHERE IT MEETS SHERRY LANE, SOUTH; TO ESTABLISH AN AMENDED LIST OF ENUMERATED LOCATIONS WHERE STOP SIGNS WILL BE PLACED; TO PROVIDE TRAFFIC CONTROL AT THE INTERSECTIONS; MAKING OTHER FINDINGS AND PROVISIONS RELATED THERETO; PROVIDING FOR SAVINGS, SEVERABILITY, AND REPEALING CLAUSES; PROVIDING FOR AN EFFECTIVE DATE AND PROVIDING FOR THE PUBLICATION OF THE CAPTION HEREOF.**

**WHEREAS**, the City Council of the City of Krugerville, Texas (“City Council”) has previously adopted ordinances, rules and regulations governing the location of stop signs within the City Limits; and

**WHEREAS**, the City Council desires to amend its Code of Ordinances by amending Article 12.300, Section 12.301, an enumerated list of stop sign locations, with the addition of three stop signs; and

**WHEREAS**, the City Council has determined that amending its Code of Ordinances is in the best interest of the public health, safety, and welfare of the citizens of the City of Krugerville;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KRUGERVILLE, TEXAS:**

**Section 1. Recitals Incorporated.** The above-referenced recitals are incorporated herein as if set forth in full for all purposes.

**Section 2. Amendment.** Article 12.300 Stop Sign Placement and Enforcement, Section 12.301, is hereby amended as follows:

STOP signs shall be placed at the locations shown below:

- (7) Northbound lane of Johnson Lane & New Hope Road at Cortes Street
- (8) Southbound lane of Johnson Lane & New Hope Road at Cortes Street
- (9) Northwest corner of Sherry Lane where it meets Sherry Lane, South

**Section 3.** The Mayor or Mayor Pro Tem is authorized and directed to cause the placement of proper signs along the above described streets.


**Section 4.** It shall be unlawful for the driver of a vehicle to disobey the instruction of the signs placed in accordance with the provisions of this ordinance unless at the time otherwise directed by a Police Officer.

**Section 5. Savings, Severability and Repealing Clauses.** All ordinances of the City in conflict with the provisions of this ordinance are repealed to the extent of that conflict. If any provision of this ordinance shall be held to be invalid or unconstitutional, the remainder of such ordinance shall continue in full force and effect the same as if such invalid or unconstitutional provision had never been a part hereof. The City declares that it would have passed this ordinance, and each section, subsection, clause, or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional or invalid.


**Section 6. Publication of the Caption Hereof and Effective Date.** This ordinance shall be in full force and effective from and after its passage and upon the posting and/or publication, if required by law, of its caption and the City Secretary is hereby directed to implement such posting and/or publication.
