## Swimming Pool Permit Submittal Requirements

### Swimming Pool Permit Application

- Completed form
- List the value
- List all subcontractors
  - Note: All subcontractors must be registered with the City of Krugerville before permit will be issued.

**Site Plans (plot plans)** drawn to scale of 1' = 20' on 8.5 X 11 or 8.5 X 14 paper.

- Show location and dimensions of property line
- Show location and dimensions of any house or structure, septic tank, lateral lines or spray heads and spray field.
- Show the proposed location and dimensions of the swimming pool and decking (including distance from any existing structures and septic)
- Show the location and description of fence/enclosure

**Electric Company** must sign off on site plan.

Additional Requirements - Residential pools shall conform with the International Residential Code for pool fencing. (Chapter 3, Section 305.2.1 through 305.7)



## COUNTYWIDE INSPECTION SERVICES

### **Permit Submittal**

All completed permit documents shall be submitted to City Hall. Processing time is 7 to 10 days.

### **Permit Issuance**

Once the permit has been approved, the requestor will be contacted by City Hall personnel and notified of fees.

### **Plan Review**

Countywide Inspection Services will be conducting residential and commercial plan reviews. The applicant will be contacted by Countywide if additional information is needed. You may contact City Hall for the status of your permit at 940-365-5833.

### **Inspection Requests**

Please contact Countywide Inspection Services to request inspection(s). Any of our permit technicians can assist you. Inspections shall be requested 24 hours in advance. Those inspections requested during normal business hours, will be performed the next business day.
